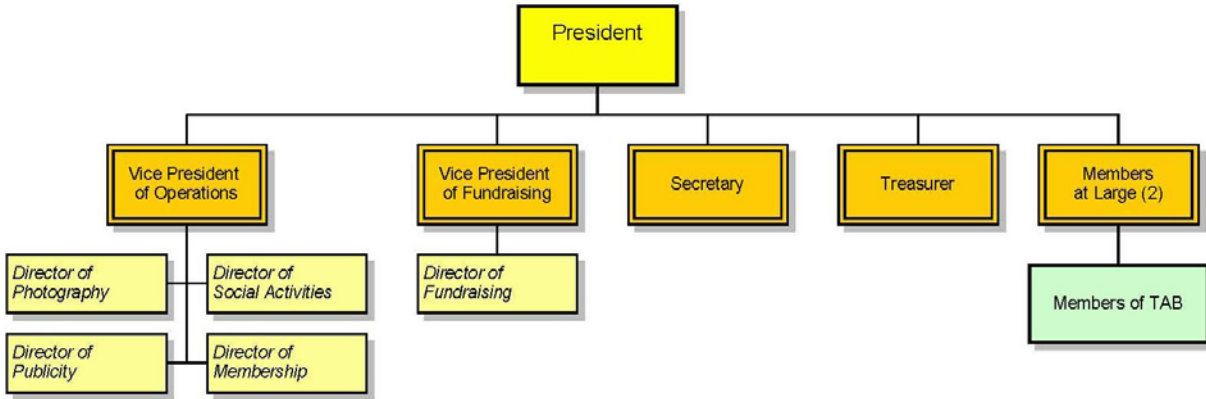
General Information

TAB BOARD OFFICERS (Voting Members)

President

- Preside at all membership meetings.
- Present at each annual meeting of the organization an annual report.
- Approve all committees, temporary or permanent.
- See all books, reports and certificates required by law are properly kept or filed.
- Be one of the officers who may sign the checks or drafts of the organization.
- Have such powers as may be reasonably construed as belonging to the chief executive of any organization.

Vice President of Operations

- In the event of the absence or inability of the President to exercise the office become acting president of the organization with all the rights, privileges and powers as if he/she had been the duly elected president.
- Oversee the progress of all committees.
- Exercise all duties incident to the Office of Vice President.

Vice President of Fundraising

- Oversee the progress of all fundraising activities.
- Give guidance to the Director of Fundraising

Secretary

- Shall be responsible for keeping records of Board actions.
- Take minutes at all board meetings.
- Ensure minutes are posted on the website in a timely manner.
- Assure that corporate records are maintained.
- Exercise all duties incident to the Office of Secretary.

Treasurer

- Have the care and custody of all monies belonging to the organization.
- Be one of the officers who may sign the checks or drafts of the organization.
- File all required financial documents with state and federal agencies.
- Shall make a report at each Board meeting.

Members at Large

- Listens to membership and communicates their issues, needs and interests to the Board of Directors.
- Work effectively toward common goals as a team member.

DIRECTORS AND GENERAL MEMBERSHIP

Director of fundraising

- Responsible for having the correct paperwork filled out regarding fundraising ideas.
- Presents ideas to the board for approval.
- Coordinate fundraising volunteers for each event.
- Reports directly to the Vice-President of Fundraising.

Director of Photography

- Coordinates team photo.
- Takes pictures of approved athletes for the use of displaying in the gym and website.
- Reports directly to the Vice-President of Operations.

Director of Publicity

- Coordinates media events with GAR coaching staff and notifies the TAB board accordingly.
- Reports directly to the Vice-President of Operations.

Director of Social Activities

- Responsible for planning social events for the teams and sending cards, flowers, etc. to athletes.
- Reports directly to the Vice-President of Operations.

Director of Membership

- Updates the team directory
- Meets with new members, hands out TAB information packets
- Collects different organization fees.
- Answers questions from parents
- Communicates to the president and head coaches if needed.

Owner of Gar and General Manager

- Oversees TAB
- Provides input and ideas helpful to TAB
- Is a lifetime member.

- All team parents are required to be members.

FUNDRAISING

One of the main purposes of TAB is to raise funds in order to offset the competitive expenses throughout the season, as well as supporting equipment needs of our athletes and coaches. It is required for TAB members to participate in all fundraising events as well as team oriented activities.

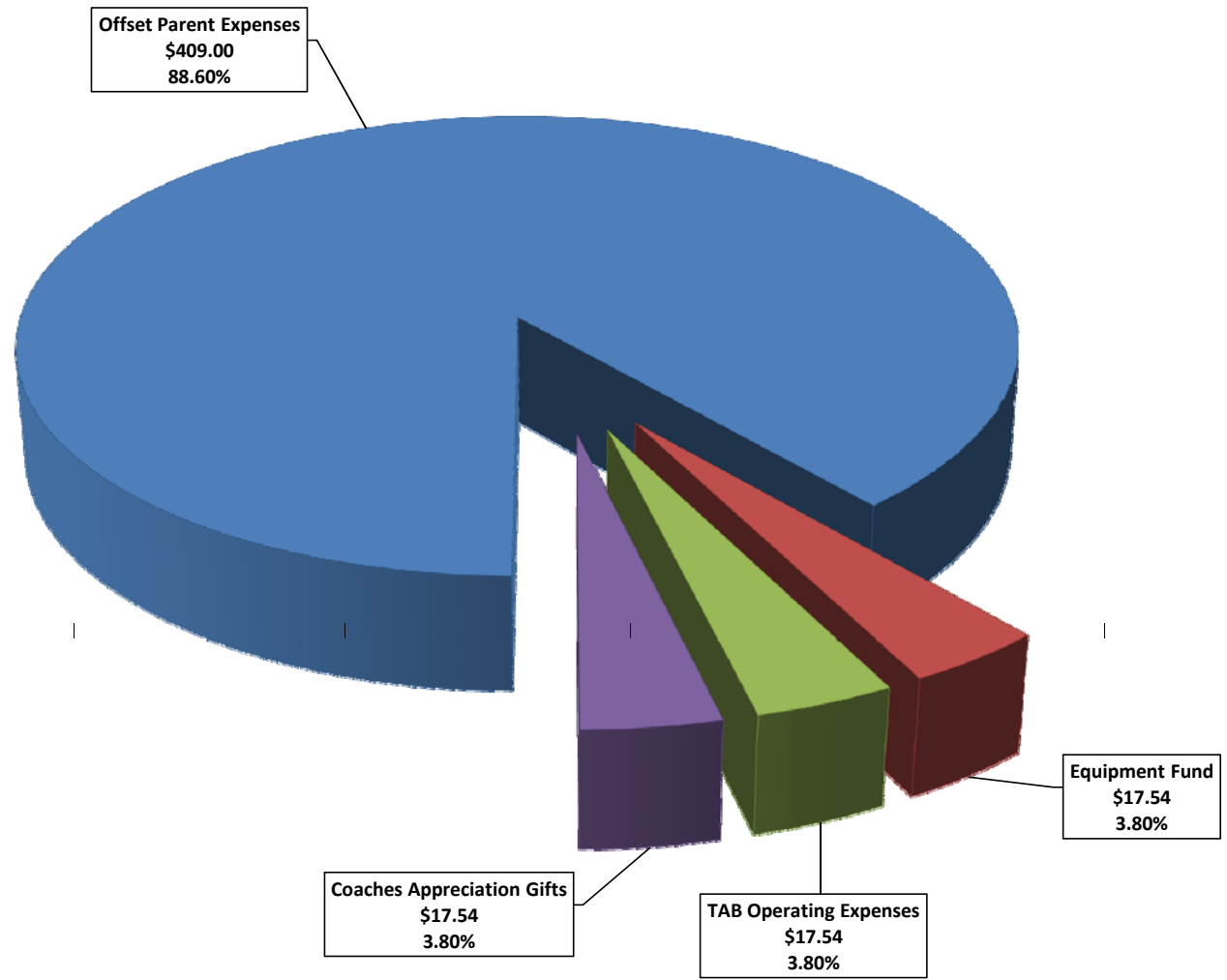

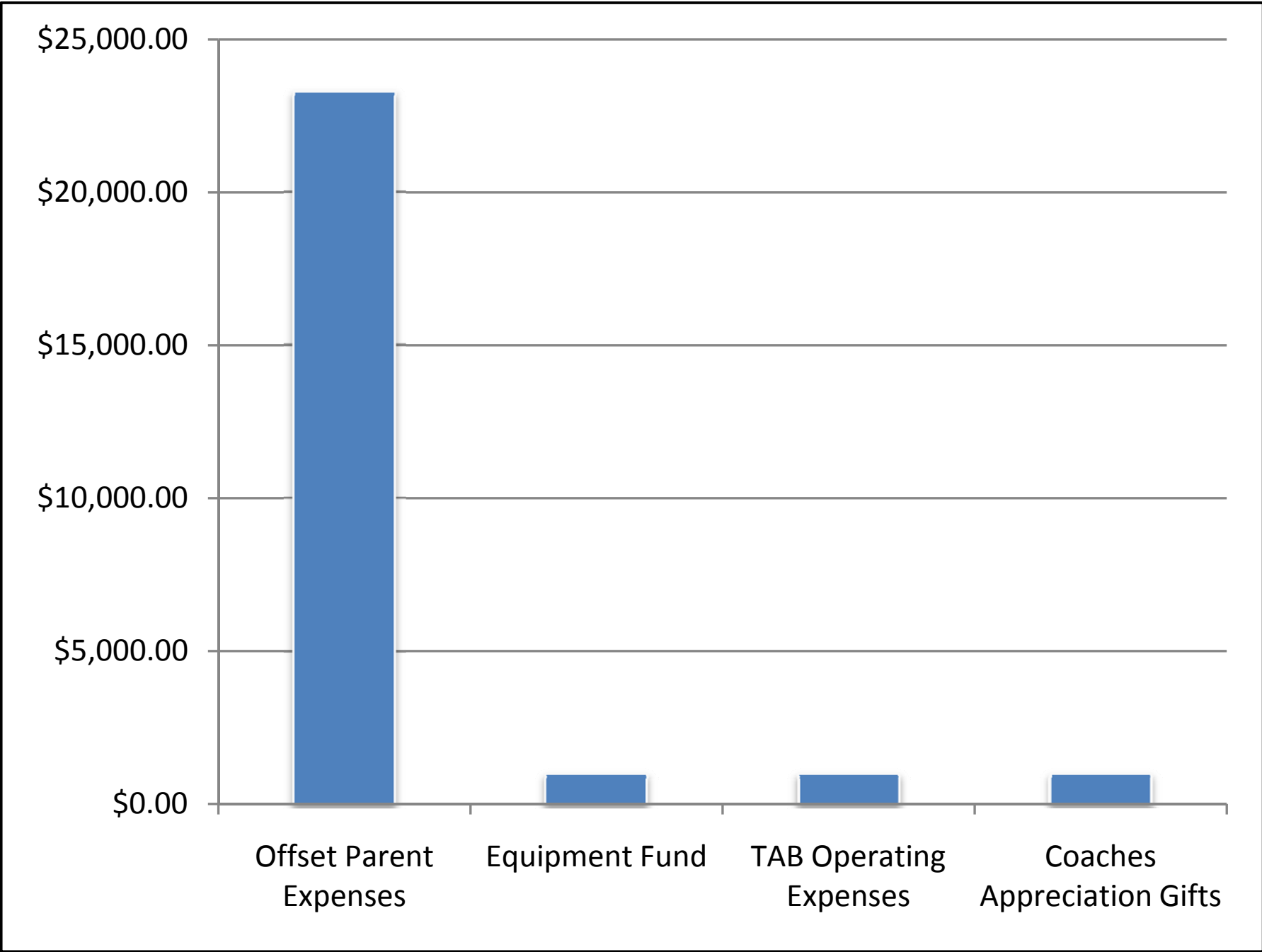
